ORDER

Approval of the competent authority is hereby conveyed for promotion of 185 Programme Executives/equated categories, as per Annexure, to the grade of Junior Time Scale (JTS)/Assistant Director (Programme) (Group-A in the Pay Band-3; Rs. 15,600-39,100/- + Grade Pay Rs. 5400/-) of Indian Broadcasting (Programme) Services (IBPS) purely on 'ad-hoc' basis for a period of six months i.e. upto 31.12.2016 or till retirement or till the posts are filled up on a regular basis or until further orders, whichever is earlier. The 'ad-hoc' promotion of the officers mentioned in Annexure is subject to the following conditions:

- i. The ad-hoc promotion shall not confer any right to continue in the grade of JTS of IBPS/Assistant Director (Programme) beyond 31.12.2016 or for regular appointment or to claim seniority in the Grade;
 - ii. Ad-hoc appointment may be terminated at any point of time without giving any reasons therefor;
 - iii. The appointment on ad-hoc basis will take effect from the date of assumption of charge of the post of JTS/Assistant Director (Programme);
 - iv. The service rendered on ad-hoc basis in the JTS Grade/Assistant Director (Programme) would not count for the purpose of seniority in that grade or for promotion to the next higher level;
 - v. The officials who fail to avail ad-hoc promotion in respect of the instant order would not be reconsidered for ad-hoc promotion for this period.
 - vi. All the officers will stand automatically reverted to their respective feeder grade, after the completion of the said ad-hoc promotion on 31.12.2016.
2. Prasar Bharati may issue separate orders accordingly.
