SUBJECT:- Points to be considered while granting MACP to PEXs Regarding -

All Head of Offices/Station Directors are requested that financial upgradation granted to PEXs under MACP Scheme may be allowed in accordance with Ministry of Personnel, Public Grievance and Pensions (Deptt. Of Personnel and Training)'s O.M.No.35034/3/2008-Estt.(D) dated 19.5.2010. However, some of the following points mentioned below strictly be adhered to at the time fixation of pay:-

- The MACP Scheme is applicable w.e.f. 01.09.2008 only.
- The pay of an individual is fixed as per Ministry of Personnel, Public Grievance and Pensions (Deptt. Of Personnel and Training)'s O.M. No.35034/3/2008-Estt.(D) dated 19.5.2010
- 3. No stepping up of pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under MACP Scheme.
- 4. The MACPS envisages merely placement in the immediate next higher grade pay in the hierarchy of the recommended revised pay bands and grade pay as given in Section I, Part-A and the higher grade pay attached to the next promotion post in the hierarchy will be given only at the time of regular promotion.
- Promotions earned in the post carrying same grade pay in the promotional hierarchy as per Recruitment Rules shall be counted/adjusted for the purpose of MACPS.
- Grade pay of Rs.5400/- in PB-2 and Rs..5400/- in PB-3 shall be treated as separate grade pays for the purpose of grant of up-gradations under MACPScheme.
- Past service rendered by a Govt. employee in State/Govt/Statutory body/Autonomous body/public Sector organization before appointment in the Govt. shall not be counted towards Regular Service.
- Regular Service shall include all periods spent on deputation/ foreign service, study leave and all other kind of leave, duly sanctioned by the competent authority.

- If a financial upgradations under the MACPS is deferred and not allowed after 10 years in a grade pay due to the reasons of the employees being unfit or due to departmental proceedings etc., this would have consequential effect on the subsequent financial upgradation which would also get deferred to the extent of dealy in grant of first financnail upgradation.
- If a regular promotion has been offered but was refused by the employee before becoming entitled to a financial upgradatiuon, no financial upgradation shall be allowed. He shall, however, not be eligible to be considerd for further financial upgradation till he agrees to be considered for promotion again and the second next financial upgradation shall also be deferred to the extent of period of debarment due to the refusal.

Points to be considered while granting MACP to PEX/ equated cadres & TREX/equated cadres regarding.

In continuation of this Directorate's letter of even number dated 19.02.2010 regarding points to be considered while granting MACP to PEXs, the undersigned is directed to further issue the following guidelines in order to clarify certain points which are being received in this Directorate from various Stations of AIR. The stations may therefore adhere to the instructions given below.

- The decision to grant MACP to programme cadres was taken in DG:AIR after taking into consideration all relevant facts. Hence no further clarification as to the applicability of MACP to subordinate programme cadres by any office shall be entertained in future.
- 3. After issue of necessary MACP orders by the Competent Authority, the benefits of MACP to PEX/ equated cadres & TREX/equated cadres are to be extended after completion of 10/20/30 years of service from their date of direct appointment in the **immediate** next higher grade pay in the hierarchy of the recommended revised Pay Bands and Grade Pay of Sixth Pay Commission.
- 4. The Service Book of the respective individuals may be verified at the Station/Kendra level for any doubt on the points and the date of entry into Government Service on regular basis as per entries made in the service book shall be final. The upgradation given at the time of promotion should be set against the benefits given under MACP.
- The calculation shall be done as per the below mentioned table:
