Subject : Efforts to sabotage grant of MACP to subordinate Engg. & Prog. Cadres through Audit Objections .(A conspiracy to disturb Cordial atmosphere in the department)

Respected Sir,

With warm regards this is to bring to your kind notice about continuous efforts being made from unknown corners to put hurdles in the implementation of MACP to subordinate Engg. & Program cadres with the conspiracy to spoil the cordial atmosphere of the department.

Pl. note MACP to sub ordinate Engg. and program cadres was granted as per 6<sup>th</sup> CPC recommendations , as we all are Govt. Employees and have not joined Prasar Bharati till date. On the same basis the All Indian Radio & Doordarshan Employees who are working in Prasar Bharati on deemed deputation are granted benefit of 6<sup>th</sup> CPC at par with all other Central Govt. Employees. It is also pertinent to mention that the same is admitted before Hon'ble Supreme Court and Hon'ble Group of Ministers constituted for this purpose has also taken the same decision.

In a recent incident an objection has been raised by PAO in West Zone and it has stopped the further implementation of MACP and also it is also a threat to withdraw MACP already granted to the staff.

In the objection it is also pointed out that Sub ordinate Engineering and Program staff has been granted so called upgraded Pay scale by an order of dated 25<sup>th</sup> Feb 1999. It is highly objectionable that facts are being presented to Audit Parties in concocted manner and it is being done by some corners who are friendly to another Association (opposing the grant of MACP) on the pretext if these cadres have been granted one upgradation. It is also very worthy to mention that SSS of ARTEE, ADTEA & PSA has proved number of times the whole story behind these scales with facts and proofs. Pl. note that benefit of 6<sup>th</sup> CPC were granted to us without considering 25<sup>th</sup> Feb 1999 as an upgradation.

In the light of above said facts it is strongly pleaded that such type of objections and efforts whatsoever it is to stop the implementation of MACP are not in the interests of the cordial atmosphere of the department. We want to reiterate our clear stand that in case of any interruption this SSS of ARTEE, ADTEA & PSA will have no option except to go on agitation steps which will subsequently jeopardize the functioning of the department.

An early action in this regard is expected to avoid any type of interruption in implementation of MACP.
