OFFICE ORDER NO. 167/2014-PPC.

The following AD(P)/JTS level officers working on ad-hoc basis in All India Radio / Doordarshan are promoted, purely on ad-hoc basis as DD(P)/Senior Time Scale of IB(P)S PB-3, Rs.15,600-39,100 + GP Rs.6.600/- initially for a period of one year w.e.f. the date they assume charge of the post or till the regular incumbents become available or until further orders, whichever is earlier:

- (ii) the adhoc promotion would be subject to the outcome of the court cases relating to this grade; and
- (iii) that the ad-hoc promotion is being made without prejudice to the interests of the parties involved in litigation in the various courts, if any, relating to the post concerned and would be subject to decisions of respective Hon'ble courts.

3. The posting orders in respect of these officers may be issued by the DG, DDn / DG, AIR keeping in view the vacancy position.


