**OFFICE ORDER NO.3/2012-S.1**

In pursuance of DOP&T's OM No. 35034/3/2008-Estt.(I) dated 19.05.2009, the competent authority has approved the 1<sup>st</sup> and 2<sup>nd</sup> financial up-gradation to Production Assistant (39 in total) having vigilance clearance on completion of 10 and 20 years of regular service as mentioned in enclosed Annexure from the present Grade Pay to the next Grade Pay under Modified Assured Career Progression Scheme (MACPS) with effect from 1.09.2008.


2. The MACP's envisages merely placement in the immediate next higher grade pay in the hierarchy of the recommended revised pay bands and grade pay as given in Section-1 part-A of the first Schedule of the CSS(Revised Pay) Rules, 2008. Financial Up-gradation under MACP Scheme shall be purely personal to the employees and shall have no relevance to his/her seniority position.

3. The pay of the officials will be fixed as per the provisions of Para 4, 6.1 & 7 of Annexure to DOP&T's OM dated 19.05.2009.

1. The above pay fixation is subject to post audit and in the light of audit observation, further clarification from Prasar Bharati, Ministry of I&B, DOP&T, inadvertent administrative & clerical mistake, typographical error etc. over-payment, if any, shall be recovered from them, in lump-sum.
