In pursuance of DOP&T's O.M. No. 35034/3/2008-Estt. (D) dated 19th May, 2009 & subsequent clarifications on MACP Scheme and acceptance of the recommendations of the duly constituted Screening Committee, the Competent Authority has accorded approval to grant the 1st, 2nd and 3rd financial up-gradation on completion of 10, 20 and 30 years of regular service in the grade to the ad-hoc DD(P)s/ASDs of AIR and Doordarshan mentioned in the Annexure as per details given against each.

2. Head of all Stations/Kendras/Offices of AIR/DDn are requested to recheck the service particulars/penalty statement/vigilance clearance in respect of these officers scrupulously and in case of any doubt refer the matter to this Directorate for clarification before the pay fixation.

3. The above mentioned financial up-gradation is purely personal to the employee concerned and shall have no relevance to his/her seniority position. Further, this financial upgradation is subject to the relevant instructions/orders on MACPs issued from time to time.
