

OFFICE MEMORANDUM

Subject: Request for considering employees of Doordarshan and AIR (recruited upto 5.10.2007) who are under deemed deputation to Prasar Bharati as eligible category under Priority -1- for Grater Noida Housing Scheme (CGEWHO).

The undersigned is directed to enclose herewith a copy of the NFADE letter dated 14/2/2011 requesting for consideration of employees of Doordarshan and AIR who are Central Government employees under deemed deputation to Prasar Bharati as eligible category under Priority-1 for Greater Nodia Housing Scheme of CGEWHO. National Federation of Akashvani and Doordarshan employees (NFADE) has stated that Office of CGEWHO is not accepting the applications of Doordarshan and AIR employees for their housing scheme for Greater Noida on the plea that Doordarshan and AIR are under Prasar Bharati, an autonomous organization under Ministry of I&B. Hence they are not eligible as Central Government employees under Priority-I.

2 It is clarified that though Prasar Bharti is an autonomous organization yet the regular employees of Doordarshan and AIR which have been recruited upto 5.10.2007 are Central Govt employees on deemed deputation to Prasar Bharati and they will continue to be government servant till their retirement. Hence, it is requested that they may be treated as Central Govt servants as eligible category under Priority-1 which is meant for Central Govt employees for Greater Nodia Housing Scheme. A copy of this O.M. is being enclosed to Prasar Bharati who is being requested to confirm the status of employees whether he is regular government servant appointed before the cut of date i.e. 5.10.2007 while forwarding the application to CGEWHO.
