Respected Ma'am,

1. I on behalf of our members wish to congratulate your kindself for taking over as the new Director General of All India Radio. I wish to humbly submit to your kindself that our Association is the largest (more than 200 units all over India) & oldest (started in January 1961) and assure of supporting any steps your kindself may contemplate in improving the effectiveness & efficiency of AIR.

2. I wish to bring to your kind notice an issue that that needs to be resolved taking into consideration the stagnation among Transmission Executives (TREXs) working without a single promotion for the past more than 24-25 years and also the Hon'ble Court Decisions (Delhi, Ernakulam, Cuttack, Bangalore, Srinagar & Jaipur) on Variable Ratio in Promotions (taking into consideration the respective strengths among the TREXs & regularized DD Production Assistants) as per the Recruitment Rules.

3. In this regard, I wish to bring to your kind notice the direction by **CAT Cuttack on 24.12.2019 (OA.No.811/2019- Annexure.1)**, and the related Judgements by different Courts on the Ratio principle followed in the **2008 PEX DPC (3 :1)**.

4. The court orders in the PEX DPC Ratio (3 :1) include the ones by **Hon'ble CAT Delhi on 21.10.2010 (OA.No.2762 / 2008- Annexure .2)**, **Hon'ble High Court of Jaipur** order dated **05.04.2018 (WP.Nos.13581, 13583/2011 - Annexure. 3)**, Order of Hon'ble High Court of **Jammu & Kashmir dated 14.02.2019 (SWP.No.798/2015 - Annexure. 4)** and the direction of **Hon'ble High Court of Jaipur on 08.05.2019 (DBW.MA.No.50/2019 - Annexure . 5)**.

5. I once again wish to state that all the above Judgements not only upheld the ratio principle, but also the PEX DPC of 2008 which followed the 3 : 1 ratio.. **Any legal opinion contrary to the above orders would border on contempt against all the above orders**

6. The above stated points would also be in consonance with the Hon'ble Ernakulam CAT Judgement dated 19.08.1997 (OA.No.945/1995) and the Hon'ble CAT Bangalore Judgement dated 12.03.1997 (OA.No. 2214/1991995) and the Speaking Orders issued 26.08.2011 and 19.11.2012 (Annexure. 6) by the AIR Directorate.


7. Following the RR would do justice to the hundreds of TREXs recruited by Staff Selection Commission (SSC) by way of an Open All India Advertisement, Written Competitive examination followed by interview vis-à-vis the serving DD Production Assistants who were either regularized by the 1992-94 regularisation scheme or recruited locally.


8. **Once again I pray to your kindness to avoid disturbing the seniority of more than 20 years among PEXs and also follow the Recruitment Rules (23.10.1984) and the several court directions on variable Ratio in PEX Promotions.**
