
Sub: The scheduled DPC in the JTS Cadre of IBPS -Reg
Ref: DG-AIR Circular dated 06.05.2016 on furnishing of ACR / APAR.


Sir,

This is with reference to the scheduled DPC in the JTS Cadre of IBPS at Prasar Bharati under your kindself's Chairmanship. In this context we wish to bring to your kind notice the circular by DG-AIR, whereby the ACR / APAR of many of the PEXs have been sought. In this regard, we wish to submit that due to the non-convening of DPCs for the last 26 years, some of the PEXs might have missed writing / submitting their ACR / APAR due to frustration. For many of them shown in the list, ACR/APAR have been despatched by their respective office, and it is not the fault of the candidate that the ACR / APAR are shown as missing. Even in the absence of requisite number of ACRs / APARs, the DPC can consider resorting to the DOPT guideline dated 10.04.1989, which mentions as extracted below,


“ Para.6.2.1(c) Where one or more CRs have not been written for any reason during the relevant period, the DPC should consider the CRs of the years preceding the period in question and if in any case even these are not available the DPC should take the CRs of the lower grade into account to complete the number of CRs required to be considered as per (b) above. If this is also not possible, all the available CRs should be taken into account “ (No.22011/5/86-Estt(D)

Taking into consideration the fact that it is a adhoc promotion on the basis of Seniority-cum-Fitness (non-selection method), and the senior PEXs are being considered for it after completing more than 21 to 25 years, while the eligible service for promotion as per the 6th CPC is only TWO years, we pray that the DPC may kindly be convened at the earliest and all those eligible and clear from the Vigilance angle may be promoted.
