Respected Sir,

We wish to bring to your kind notice the plight of All India Radio & Doordarshan, which as the Nation's Broadcaster have to perform the role of an empowering platform, so as to enable our citizens make informed Choices / decisions. The Programme staff form the core cadres in AIR & DD, as they are tasked to Plan, Produce and Schedule Programmes for Broadcast. The above mentioned role, which calls for the effective and efficient management of all the AIR and DD stations all over the country, is suffering, while the Audience share for AIR & DD is plunging and its revenue is dwindling due an extraordinary situation whereby, more than 95% of its supervisory posts in Indian Broadcasting Programme Service (IBPS) are lying vacant. They are lying vacant as UPSC is yet to convene the Court directed Review DPC in JTS Cadre from 1990 to 1993, and the consequential DPCs in the STS, JAG and SAG Cadres from 1990 upto March 2016. The Hon'ble CAT New Delhi after a lot of discourse and consideration had on 04.11.2015 directed UPSC to convene all the pending DPCs up to 31.03.2000 within a period of three months i.e 28.02.2016 (Copy attached) . This direction was given after taking into consideration the Prasar Bharati Amendment Act of 09.01.2012. The counsel for UPSC was witness to the above court proceedings. Now, around six months have gone by since the direction, and we are yet to see the compliance of the direction by UPSC. Taking into consideration the dire straits of the Nation's Public Service Broadcasters (AIR & DD),the Hon'ble Court directions and the anxiety among large number of staff superannuating every month, we humbly pray to your kindself to complete the pending





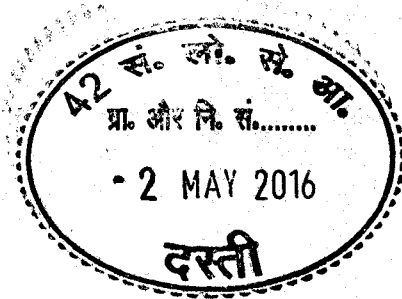
