Subject : ***View point of Sanyukta Sangharsh Samiti of ARTEE.ADTEA & PSA on Pay Scales order dated 25th Feb 1999.***

Respected Sir,

With appropriate regards this is in reply of your letter no. A-10/227/2006-PPC Vol-III(pt.II(a)) datd 27.07.2011 asking the Associations to submit their view point on so called upgradation of Pay scales of 11 categories as per order issued on 25.02.1999. We hereby want to submit the following.

[1]. Your letter is referred to Sh. Anilkumar S., Chairman, NFADE. The issue of Pay Scales pertains to individual Associations, mainly ARTEE.ADTEA and PSA (the prominent constituents of Sanyukta Sangharsh Samiti). ***It was pointed out in letter submitted by NFADE vide letter no. NFADE/MIB/2011/03 Dated 15/03/2011 to Hon'ble Minister of I & B (Copy of letter enclosed)also.***

[2]. The analogy of Restoration of Pay Scales is being submitted is enclosed in Details.


[3]. ***Hon'ble Supreme Court granted Pay Parity to Engg.Asstt. with Sound Recordist of Doordarshan who got the Parity with Sound Recordist of Films Division. Similarly, Hon'ble Supreme Court granted pay parity for Transmission Executives with Engineering Assistants vide its order dated 14.03.1996. The Scale of Sound Recordist was downgraded by 5th Pay Commission, But never implemented for them, they all retired in the same scale i.e. Rs. 550-900 (3rd CPC), Rs. 2000-3200 (5th CPC), Rs. 6500-10500 (5th CPC) and neither downgraded nor treated as upgraded.***




Various courts of the country have also upheld the pay scales of Engineering Assistant / Transmission Executives in different cases. Hence there is no justification for withdrawal of pay scales granted vide order dated 25.2.1999.


In the light of above and enclosed facts it will be against the verdict of Hon'ble Supreme Court and against the law of natural justice as per clause 14 and 16 of Indian Constitution to even reconsider the order dated 25.2.1999.




