

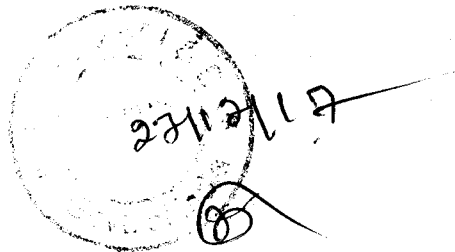




Sub : Amendment to the PEX RR to make it a 100% Promotion post.
Ref : Communications from Prasar Bharati dated 20.10.2015, 16.11.2015 and 09.02.2017.


Respected Sir,

We wish to bring to your kind attention a decision pending in the Ministry from February 2017 concerning an amendment to the PEX RR. In this regard, **Prasar Bharati Board in its 128th Board meeting had passed a resolution (Agenda : E-5) whereby, it was decided to make the PEX post a 100% Promotion post in order to remove stagnation in the feeder cadres to PEX post.** The initial letter on the basis of the Prasar Bharati Board resolution of 07.09.2015 was sent to the Ministry on 20.10.2015 (Annexure.1), which was followed by communications dated ~~20.07.2016~~ and 09.02.2017 (Annexures-2 & 3) in response to Ministry letter dated 04.11.2015 (Annexure.4).

There are **two pending LIVE cases at CAT Hyderabad (OA.No.1338 / 2014) and at CAT Ernakulam (OA.No.225 / 2013), where the courts have already directed consideration of PEX insitus against the PEX DR vacancies, so as to remove stagnation in the feeder cadres. Taking into consideration the court directions and Board resolution, we pray that the Amendment to PEX RR be approved at the earliest, and pending approval the PEX insitus be promoted to the large number of vacancies in the PEX cadre.**
