OFFICE ORDER

Sub: Promotion to the Junior Time Scale (JTS) of Programme Management Cadre (PMC) of AIR/Doordarshan and Junior* Time Scale (JTS) of Programme Production Cadre (PPC) of AIR/Doordarshan (Group "A", pay scale Rs. 2200-4000/pre-revised) in the Ministry of Information & Broadcasting for the vacancy years 2000-01 to 2018-19 (up to 31.12.2018).

In pursuance of the approval of the recommendations of the DPC convened in the Prasar Bharati on 12th December, 2018 by the Ministry of I&B vide its letter no. A-32013/05/2017-BAP dated 10.04.2019, the officers as mentioned in Annexure-1 and Annexure-2 are promoted to the **(i)** Junior Time Scale of Programme Management Cadre of All India Radio/Doordarshan and **(ii)** Junior Time Scale of Programme Production Cadre of All India Radio/Doordarshan (along with media i.e. AIR/DD) respectively of Indian Broadcasting (Programme) Service with effect from the date they assume charge of the post and until further orders.

2. The promotion will be subject to following conditions:-
 - i. The promotion will have **only prospective effect even in cases where the vacancies relate to earlier year(s) as provided in** para 2.4.4 of DoP&T's OM No. F.22011/5/86-Estt.D dated 10.03.1989.
 - ii. These promotions will be subject to final outcome of Writ Petition No. 15604/2019 filed before Hon'ble High Court of Karnataka.
 - iii. The promotion order is subject to further order which may be passed by the Hon'ble Supreme Court as per DoP&T's OM No. 36012/11/2016-Estt.(Res-I){Pt.-II} dated 15.06.2018.
3. This order is in compliance of the Order dated 04.11.2015 of the Hon'ble CAT, Principal Bench, New Delhi, issued in C.P. No. 39/2004 in OA No. 243/2002 filed by Programme Staff Association in All India Radio & Doordarshan & Ors.
